1. Approval of minutes for June 8, 2015 Academic Committee Meeting

2. Review manuals and procedures for the 2015-16 School Year

The Committee noted the high quality of all of the manuals. Head of School Saba was commended for the thoroughness of the materials and also their supportive and respectful tone. The manuals were viewed as providing an excellent summary of The Academy's operations in key areas.

a. 2015-16 Athletic Handbook

b. 2015-16 Safety Procedures

Discussion of the Safety Procedures document. Nicole Washington motioned to recommend this document to the Board for review; seconded by Marian Bergeson; all in favor.
